Happy Retirement BP!



You may have noticed a significant figure missing at training recently, and we are saddened to announce that Brad Peterkin is hanging up the whistle in 2019.

BP has made a huge contribution to refereeing in Northern NSW, on and off the field, since joining State League Referees in 2003. A first grade veteran, BP has officiated 11 FFA Cup matches, 5 Herald Women's Premier League matches, and over 100 NEWFM Northern League One and NPL Northern NSW matches, including 1 NewFM grand final as a referee and 4 as a fourth official. He was the first Peterkin to referee a NewFM u19 Grand Final and was named Coalfields All Age Soccer Association Referee of the Year in 2003.

Over the last few years, Brad has acted as the Association and Federation appointed trainer, has assessed and mentored referees in youth grades, and was awarded Life Membership of our Association in 2018.

Laws of the Game - Advantage by Murray Ross

The Referee plays advantage perfectly when they let the non-offending team build up an attack, but where do you apply the advantage?

The Laws Of The Game are clear on this subject. "The referee allows play to continue when an offence occurs and the non-offending team will benefit from the advantage and penalises the offence if the anticipated advantage does not ensue at that time or within a few seconds."

If the offence committed requires a Caution to the Offending team, where and when does this caution come into play?

"If the referee plays the advantage for an offence for which a Caution/Send-Off would have been issued had play been stopped, this Caution/Send-Off must be issued when the ball is next out of play, except for the denial of an obvious goal-scoring opportunity when the player is cautioned for unsporting behaviour."



However, there are certain scenarios where referees DO NOT apply advantage. "Advantage should not be applied in situations involving serious foul play, violent conduct or a second cautionable offence UNLESS there is a clear opportunity to score a goal. The referee must send-off the player when the ball is next out of play, but if the player plays the ball or challenges/interferes with an opponent, the referee will stop play, send-off the player and restart with an indirect free kick unless the player committed a more serious offence."

Things to consider when playing advantage include:

- The severity of the offence if the offence warrants a sending-off, the referee must stop play and sendoff the player unless there is a clear opportunity to score a goal
- The position where the offence occurs the closer the incident to the players own goal, the less beneficial an advantage would be, however, the closer to the opponent's goal, the more effective the advantage can be; and
- The Chances of an immediate, promising attack

Remember, if a defender starts holding an attacker outside the penalty area and continues holding him/her inside the penalty area, the referee must award a penalty kick.
