



# 2020 TRIAL GAME APPLICATION FORM

This form is to be emailed to [operations@ffnc.net.au](mailto:operations@ffnc.net.au)

- This application form is to be used for a trial (or friendly) between clubs affiliated with an FFA Member Federation.
- All players must be either registered or intending to register for season 2020 to participate.
- Application for each Trial Fixture must be submitted "not less" than 7 working days from the proposed fixture. (\*\*Trials against teams outside the Zone requires at least 10 days notice).
- Trials between two FFNC teams require an application from BOTH clubs.
- FFNC will facilitate applications to NNSWF or other State Bodies where applicable, upon receipt of a Trial Application form from a FFNC member club.
- Trial fixtures are only considered sanctioned when written approval has been issued by FFNC.
- Match Officials MUST be appointed by FFNC for fixtures within the zone, unless otherwise advised by FFNC.
- Match Sheets to be submitted by participating FFNC teams for all fixtures after each trial.
- Red Cards issued in Trial fixtures will be assessed in accordance with the severity of the offence.
- Sanctions accumulated from past competitions cannot be served in trial fixtures.
- Suspended players ARE eligible for Trial Fixtures (UNLESS subject to a time suspension).
- Match Officials to be paid on the day of trial, in cash by participating clubs at rates applicable per the 2020 Match Officials Fee Schedule.
- Appointment of Referee and Assistant Referee's are subject to availability of match officials.
- Approval for a trial fixture is withdrawn if the ambient temperature during the fixture exceeds 34 Degrees Celsius (senior games) or 30 Degrees Celsius (junior games).
- Play must be suspended if there is any storm activity (specifically severe lighting) in the immediate locality (i.e. within 10kms).
