

## FFNC Match Officials Payments - 2020 Schedule for the information of INDIVIDUAL MATCH OFFICIALS

Payments to all match officials will be made fortnightly via direct credit into the nominated bank account of respective match officials for all **COMPETITION** Fixtures.

**There will be NO cash payments to match officials for any COMPETITION fixtures.**

Trial fixture payment amounts will be advised via email to appointed match officials prior to all approved trial fixtures.

Each Individual Member Club participating in TRIAL fixtures is required to arrange CASH payment to match officials on the day of the trial. The HOME club is however ultimately responsible for ensuring that match officials receive the FULL payment due to them.
